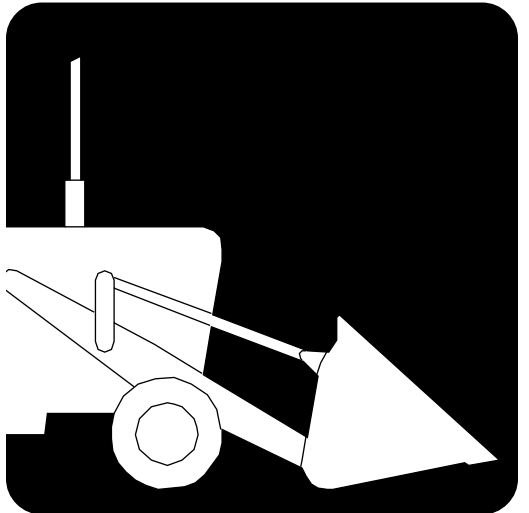

EXCAVATION PERMITS WORK IN COUNTY RIGHT-OF-WAY Permit Required

No person or the contractor of any person excepting the contractor of this County for highway construction, improvement or repair, shall make or cause to be made any encroachment including an excavation, fill or obstruction, for the purpose of installing utilities including, but not limited to: sanitary sewer, private storm drainage, domestic and irrigation water, oil and natural gas, electric power, telephone, and television signals, both main and lateral lines, without first obtaining from the Director, Department of Public Works a permit to so do.

APPLICATION PROCEDURE

The applicant shall provide the following;

- Location relative to the road Right-of-Way (R/W)
- Type of surface to be cut in R/W
- Dimensions including the length, width and depth
- Purpose, extent and nature of excavation, fill or obstruction
- Size and type of pipe when applicable
- Time during which it will exist
- Signed plans or drawings

- \$80.00 permit fee (checks payable to "County of San Diego")
- Inspection deposits
\$5.00 per lineal foot, first 1000 feet; thereafter \$1.75 per lineal foot; minimum of \$600.00 deposit.
- Licensed contractor number (The County accepts only General Engineering Class A, Excavation/ Pavement Contractor C12, Pipeline Contractor C34 or Sanitation System Contractor C42 for excavation work.)
- Contractor must also provide:
A CERTIFICATE OF INSURANCE for General Liability (\$500,000 minimum), naming County of San Diego Department of Public Works as **CERTIFICATE HOLDER**.
- Approval from utility company allowing connection to their system, "**Encroachment Only**" permit (if applicable)
- Approval from sanitation district/ company to hook into sewer system, "Waste Water Discharge" permit (if applicable)

SPECIAL REQUIREMENTS

The County's "Pavement Cut Policy" limits trenching on new and newly resurfaced publicly maintained roads.

Excavations exceeding 1,000 linear feet or using the "Rock Saw" trenching method require a pre-issuance field review.

Permanent Road Division Zones (previously known as County Service Area Roads) require a pre-issuance field review before the work can start.

Trenches exceeding five (5) feet in vertical depth require a CAL-OSHA permit. CAL-OSHA's telephone number is (619) 767-2280.

Appropriate lights, barriers, warning signs or other measures designed to protect the traveling public must be erected by the permittee.

I hereby agree to provide the indemnification as required by Chapter 2 of Division 6 of Title 8 of the San Diego County Code.

Permittee agrees that all work within the County right-of-way will be accomplished in accordance with APPROVED PLANS, the Standard Specifications of the Department of Public Works, "Special Provisions for Work Done Under Excavation Permit", Special Provisions and Specifications for Improvement of New Streets", or Regional Standard Drawings, and shall be subject to inspection and approval of the Director, Department of Public Works.

In consideration of the granting of this permit, the permittee hereby agrees to preserve and save harmless the County of San Diego and each officer and employee thereof from any liability or responsibility for any accident, loss or damage to persons or property happening or occurring as a proximate result of its negligence or the negligence of its agents, servants, employees or contractors, in the design or performance of any work herein referred to.

Any encroachment not placed in a right-of-way belonging to above signed which is prior in time and/or right to the County's right-of-way, any tank, pipe, conduit, duct or tunnel placed in the excavation or obstruction herein referred to interferes with the subsequent improvement, grading or realignment of the highway by the County, then the above signed will at their own expense remove such tank, pipe, conduit, duct, or tunnel, or relocate at a location designated by the Director, Department of Public Works. The above signed further agrees to pay any damages resulting to County of San Diego from the negligent or improper design, construction of installation of the encroachment and will restore the property crossed, as near as may be possible to its former state and so as not to have impaired unnecessarily its usefulness or will repay to County of San Diego its cost of such restoration.
